- 2. If unit is owned by <u>more than one person</u> (other than married couple) the Voting Certificate must be signed by all of the owners of the unit or the appropriate corporate officer.
- 3. A Voting Certificate is <u>NOT A PROXY OR A BALLOT</u> and may not be used as such. Only an owner or the appropriate corporate officer may be named on a Voting Certificate, <u>not a third party.</u>
